Ways to save money in the fund, to bring the cash back to black without operating from the reserves. Questions was raised if there could be money borrowed from the power department to help out with the sewer until the bonds could be refinanced at a lower cost. Consideration needs to be done to see if the Sewer utility could absorb the RD loan and the loan from the Electric Utility. Discussion was held on cost allocation for the entity departments.
