## Troy Council Work Meeting Council Chambers November 14, 2013 6:30 pm

The meeting came to order at 6:30 pm. Present: Mayor Anthony Brown And Council: Phil Fisher, Fran McCully, Joe Arts, and Crystal Denton, City Attorney Heather McDougall, and City Clerk Tracy Rebo.

**PUBLIC COMMENTS:** Fran McCully informed everyone that the Christmas Tree Lighting was scheduled for November 30, 2013. She asked the City to consider purchasing goody bags for the children. She asked about portable power and barricades for the Santa area. Discussion held. It was determined to be placed on the next agenda for a decision.

**MUNICODE CONTRACT:** Clerk Tracy Rebo advised of a new service that is less expensive for online maintenance and page printing costs. Contract termination penalties were brought up and Rebo will follow up and get back to Council.

**COLLECTION BUREAU:** Rebo advised of a new agency that offers collection services at a lesser cost and offers better feedback. Discussion followed. It was determined to revisit this topic in January.

**FITNESS TRAIL:** Rebo advised that she received information regarding the Fitness Trail and forwarded the MMIA's opinion to all Council and asked for their
