Immediately Following Public Hearing Meeting**

NICOLE NOONAN – FY15/16 EXIT AUDIT: Nicole Noonan auditor for the City of Troy gave the Mayor and Council a final report on the Fiscal Year 15/16 for the City of Troy. Ms. Noonan informed Mayor and Council that the City is in good standing and looks good. Discussion was held on the Audit Report.
