CHRIS REICHERT – Habitat for Humanity: Will be building a home in Troy on the south end of the street Riverside Avenue. Alice (Missy) Guinard is the recipient of the new home. Mr. Reichert explained what Habitat for Humanity does and how it functions. He is looking to find a place to park the builder's RV's somewhere is town. Dates that they are looking at are July 23, to August 6, August 6, to August 20, 2023. He explained that the cost of the RV spot would cost about around \$14,000 at the RV park outside of town.
